2.	Financial Situation – Current bank balance is £1,059.50	
3.	SCC Grant – LB to apply to SCC	LB
4.	Section 5 Concreting – John White kindly arranged for part of the concreting to be done on 23.9.17. This involved breaking up some areas, clearing loose stones, wheelbarrowing ready mixed concrete from delivery mixer down road, tamping down, and ridging. Cost of material so far £420. The Committee would decide what financial contribution to make to John White, when the job was completed.	Comm
5.	Future Road Repairs – Suggested that we plan for any repairs which may need doing next year.	Comm
6.	Delivery Vans – Recently two Tesco vans became stuck in the gulley further down the road and needed towing out by recovery vehicles. These drivers were following sat navs directing them from Paynesfield Rd to Ricketts Hill via unmade roads rather than Paynesfield and Ship Hill. TomTom and HEREmapcreator websites have been informed of the state of these roads and it is hoped that new sat navs will not use this route. 7.	Tatsfield Talk, and Village website, JRRA website, and Tatsfield Facebook. Road Surface opposite layby — Comments had been received that the new surface was messy and the wrong colour. A lot of the yellow powdery surface has now been washed away, but the stone surface left is a better surface than previously. i-Pave commented that this Type 1 was obtained from the same company who supplied Type 1 for the top of the road and the colour was not known before it arrived. Generally it is assumed that Type 1 is covered in tarmac. We await to hear their suggestions, but our budget will dictate what action is taken.	LB
8.	Layby Parking Sign – A new sign has been purchased but as it fits awkwardly on the tree Dave Wood will look into putting it on a post.	DW
